

CHESTER TIMES – November 13, 1915 – BUILDING STILL ON THE MOVE –  
Reports From County Districts Show That Much Work Will Be Done During Winter

As fall progresses toward the winter months there is ordinarily a falling off in the amount of new building work, but this county is the exception to the rule this year. A notable example of this is Collingdale, one of the rapidly growing smaller communities of the county. Within the last few weeks that borough has witnessed contracts awarded for many houses, and in the last few days a deal has gone through which will mean the erection of at least another score of dwellings. The Cardington and Collingdale Land Company, promoters, have just purchased from Frank B. Rhodes of Media, two tracts of ground on Parker Avenue, where it is understood that they will put up twenty dwellings. These will be of brick, semi-detached, and will sell for about \$2500 each.

Drexel, one of the progressive villages of Upper Darby Township, is getting its share of the boom which has hit that township; and the type of houses being erected of the substantial, high priced class that has made that village the exclusive residential section that it is. Two contractors have been let during the last week, and it is reported that negotiations are under way for the erection of several more.

William C. Patterson of Philadelphia, has awarded a contractor for a commodious stone and hollow tile bungalow to Harry W. Koch, a Drexel Hill contractor. This will be erected on Maple Avenue, and will cost \$5000. Harry Davis, a Philadelphia builder, has been awarded a contract for the erection of a stone dwelling for Elizabeth M. Zinetti of Philadelphia, on Runnymede Avenue, will cost \$6000.

BYWOOD IS LIVELY – Bywood, the new village along the Media and Collingdale divisions of the Philadelphia and West Chester Traction Company, line is booming as it has not done before in the few months of its existence. On all parts of the tract houses are going up, and sales of land and of houses have been frequent during the last few weeks. The cold weather will not stop the development of this tract, which is proving popular with Philadelphians because of its nearness to Sixty-Ninth Street Terminal of the elevated line.

ANOTHER \$10,000 RESIDENCE – H. A. Heulings, has awarded a contract for the erection of a handsome hollow tile home in Moylan to R. C. Ballinger & Co., Philadelphia builders, the price being \$10,500. The house is probably the largest that has been erected of hollow tile in this country and the use of this material in so fine a home shows how popular it is becoming. Fully two hundred houses have been built this year either wholly or in part of tile, these being all of the finer type of houses.

John E. McDonnugh and E. A. Howell attorneys of this city, have let a contract to Morris W. Plumley, contractor, for alterations and additions to the brick office building on Welsh Street, north of Fifth Street. No price is made public.

W. Roger Fronefield has let a contract to Herbert L. Walton, contractor, for the erection of a stone and frame garage on the rear of the Fronefield property at Moylan. The price is \$1121.

Yesterday the carpenters and laborers were engaged in setting the heavy iron beams which will support the front and which will help support the marqace to be erected.
